## LEARNING ACADEMY USE AGREEMENT – PLEASE COMPLETE BELOW

### Computer Workstation/Internet Usage Agreement:

The First Tee of Charlotte provides computer workstations and internet access to its participants as an enhancement service to educational demands of its participants. Computer access is being provided as a resource for participants of the program to utilize in support of study, research and career exploration. It is important for participants to realize that this is a privilege and NOT a right thus inappropriate behavior will result in loss of user privilege.

**Access:** Access to computer workstations and the internet is being provided to enhance participant education which The First Tee of Charlotte supports. All access gained to workstations at The First Tee of Charlotte will be available pending acknowledgment and agreement to terms of use by both Parents and Participants. In addition, The First Tee will take appropriate precautions to ensure that material accessible is appropriate for the populations served and in line with the purpose of access.

**Goals and Accessibility:** The First Tee of Charlotte will support use for completion of homework, projects, extra-curricular projects, collegiate preparation, employment searches, etc.; we will strive to provide learning opportunities for participants utilizing computers and software; and promote life-long learning with technology. Access with computers will include news and resources appropriate for research, online curricula information, education institutions, government agencies, tutorials, sports deemed appropriate and relevant to learning associated with The First Tee and a variety of other resources. **Please note that access will not be extended to any youth younger than 9 years without a Parent present.**

**Acceptable Uses:** Use of workstations/internet will be available for educational or otherwise assigned purposes. In addition, The First Tee Code of Conduct will be enforced and observed to include courtesy while utilizing facility and workstations, appropriate language, privacy of self and other participants while visiting online sites.

**Unacceptable Uses:** Transmission of any of the following will result in suspension or loss of privilege or other potential consequence deemed appropriate by the Executive Director. Please see potentially unacceptable uses below:

- Actions that may disrupt TFTC network
- Knowingly attempting or introducing viruses to the network
- Unauthorized access (hacking) into computer systems
- Encouraging or committing unlawful acts or using TFTC network to promote illegal activity
- Accessing or using threatening or obscene material
- Accessing pornography
- Using discriminatory, defamatory, offensive, or harassing statements or language including disparagement of others based on their race, national origin, gender, sexual orientation, age, disability, religious or political beliefs
- Sending or soliciting abusive or sexually oriented message or images
- Accessing material that is harmful to minors
- Violating copyright laws, including duplication of software or plagiarism
- Utilizing TFTC network for commercial purposes
- Providing political or campaign information or lobbying for a political cause or candidate unless directly connected to an instructional activity
- Operating a business for personal gain, sending chain letters or soliciting money for any reason
- Posting photographs or school work of an individual student on student-created Web pages without confirming photo and video release form has been signed by the student's parent(s)
- Forwarding personal communications without the author's prior consent; and
- Distributing material protected by trade secret.

**Monitoring and Filter:** The First Tee of Charlotte will monitor all online activities of students at all times. TFTC will maintain centralized software in order to provide control of internet and filtering. The filtering software will allow access while inhibiting access to potentially harmful, obscene, or inappropriate sites that could promote or encourage minors to engage in inappropriate or possibly illegal actions.

**Disclaimer:** The First Tee of Charlotte will not be responsible for any damages suffered, including loss of data resulting from delays, non-deliveries, service interruptions or a student's mistakes or negligence, costs incurred by students or a student's parents or the accuracy or quality of information received from the Internet. The user accepts personal responsibility for any information obtained via TFTC network.

**Security:** Attempts to tamper with the network, individual user accounts, software applications, to access the network using the name and password of another user or to share a password will result in cancellation of user privileges. Electronic mail is not guaranteed to be private; system administrators have access to all email. Email messages relating to or in support of illegal activities will be reported to the authorities and appropriate disciplinary action will follow.

**Vandalism:** Any vandalism inclusive or any malicious attempt to harm or destroy network, computer or workstations will result in the cancellation of user privileges and disciplinary action and user will be liable for all damages, including any and all service charges and other repair costs. This will also include but not be limited to uploading, creating or transmitting computer viruses or worms as well as unauthorized access is a violation of TFTC agreement and criminal law.

**Agreement:** Participants and Parents are responsible for viewing all guidelines and policies enforced under the Computer Workstation/Internet User Agreement, asking any appropriate questions for clarification, and signing at the point of registration for new membership or renewal of membership in The First Tee of Charlotte.

### Computer Workstation/Internet Use Agreement:

I understand that The First Tee of Charlotte provides computers/internet use for the purpose of study, research, and career exploration. I understand that all computer/internet access at The First Tee of Charlotte is available as a privilege and requires that I follow the guidelines of use outlined in TFTC Parent Handbook including and not limited to acceptable and unacceptable use, monitoring of my internet usage by staff, security, vandalism and TFTC disclaimer. Violations of any of these guidelines will result in a suspension of privileges (and liability for all resulting damages) at the minimum and potentially cancellation of user privileges or other consequence befitting as deemed by the Executive Director of The First Tee of Charlotte. In addition, parent use of TFTC network and/or computer workstations and internet can and will be held to the same standard if violations are deemed to have occurred. Computer access will be unavailable to Participants under the age of 9 years without the consent and presence of a Parent for the duration of use.
